#### **TRANSFER TO BEST OF BREED COMPETITION**

Dogs which, according to their owners' records have completed the requirements for a championship after the closing of entries for the show but whose championships are unconfirmed, may be transferred from one of the regular classes to the Best of Breed Competition, provided this transfer is made to the Show Secretary at least one half hour prior to the start of the earliest Conformation judging at the Show.

#### **OBEDIENCE/RALLY TRANSFERS**

Dogs which, according to their owners' records have earned an Obedience or Rally title after the closing of entries for the show may be moved up to the next class, provided this transfer is made in writing and presented to the Secretary at least 30 minutes prior to the start of each trial. Transfers may be approved, provided the next level class and judge are available and the class has not reached its limit.
